

ARTICLES OF INCORPORATION
OF

A NON-PROFIT CORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is LAKESIDE WOODS ASSOCIATION, INC.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be: 200 Capri Isles Blvd., Venice, FL 34292.

ARTICLE III

Purpose

The purpose for which the corporation is organized is to administer and enforce the Declaration of Covenants and Restrictions of the LAKESIDE WOODS Subdivision as an association and to engage in any lawful purpose or purposes not for pecuniary profit.

ARTICLE IV

Directors

There shall be three members of the initial Board of Directors of the corporation.

The method of election of the directors shall be stated in the Bylaws.

ARTICLE VI

Initial Registered Agent and Street Address

ARTICLE VII

Members

The corporation shall have members. Members of the corporation will be required to be owners of fee simple interest in the lots in LAKESIDE WOODS Subdivision. Those meeting such qualifications will be admitted pursuant to the Bylaws.

ARTICLE VIII

Bylaws

The Bylaws of the corporation shall initially be adopted by a majority of the Board of Directors. Thereafter, they may be made, altered or rescinded by the members pursuant to the provisions set forth therein.

ARTICLE IX

Amendment to Articles

The Articles of Incorporation may be amended by the vote of Sixty-Six Percent (66%) of the membership of the corporation.

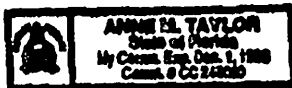
